Mrs Sandra Deaton (Chairman) welcomed all present and opened the Annual Conference 2020.

1. Annual Review

The Chairman thanked the staff for both the Annual Review which had been published digitally and the members for sending in their written questions. A limited run of printed Annual Reviews will be considered once the office reopens.

2. Return to Play

After months in lockdown due to coronavirus, Greg Yarnall, Head of Development and Volunteering made a presentation about the Table Tennis England return to play advice, called Ready to Return. The advice follows Government guidance and has been made specific for table tennis clubs and leagues.

Several attendees thanked Greg and his team for their work on this. many questions were received and clarification given. Everyone was reminded that it is best to continually check the website for the latest advice on the dedicated page. Advice regarding competitive play is Stage 3 and will be updated as soon as more government advice is received. The slide presentation is also available on the website.

A few questions were also received asking for clarification regarding insurance.



Jo Keay-Blyth advised that TTE provided insurance will be affected if Covid related. No insurance will cover Covid now unless all guidance is adhered to. Clubs and leagues were reminded that the website will be the best source of information and should eb checked regularly.

Greg Yarnall advised that regarding insurance, pre play risk assessments / method statements should be done to re-assure the facility that you are able to get back up and playing safely again. There is a checklist on the website to use so you can show you have followed the guidelines. If TTE guidelines are followed then public liability cover should be valid.

3. Membership Categories

Mrs Sara Sutcliffe introduced a short video that explained the new membership categories.

Sport England reports that almost 500,000 people regularly play Table Tennis, however we are only capturing 25,000 in our membership system as it is currently based on league and tournament play.

The objective of the review is to bring as many people into the fold of the NGB as possible.

Mrs Sutcliffe also advised that Phase 2 of the review will continue to look at other variations such as subscription models, trial or short-term memberships etc.

4. Impact Report

Mrs Sara Sutcliffe explained that it had been hoped that would be presenting a mid-way review and refresh of Mission 2025. However due to the Covid 19 crisis this was on hold so that we can properly assess the impact on the sector and the sport. Instead the Impact Report was presented. This online interactive tool provides case studies and baseline statistics against how we can measure impact of our programmes. It has been presented to Sport England who were impressed. It is alive document and will be updated.
