A Board meeting was held on the 24 March 2023 and the minutes will be available on the website.



5. Table Tennis United – Year 1 Implementation Plan

The *Table Tennis United* implementation plan for 2023/24 has been drafted and approved by the Board. I will share this at the National Council meeting.

6. Russian and Belarusian Nationals

As you may well be aware, the IOC recently published a series of recommendations for International Federations regarding the future participation of Russian and Belarusian nationals as neutrals in international sport.

DCMS are currently considering the detail of this announcement and we are staying close to UK Sport who will be engaging with them as they decide how best to respond. UK Sport will keep us updated with any further guidance it receives from Government.

7. Major Event Strategy

Work continues to build a long term major event strategy – an objective contained within *Table Tennis United*.

The strategy, which includes our intent to bid for the 2026 ITTF World Team Championships, will span across a 10 year period and involve a number of partners. The business plan, and long term modelled budget is expected to be concluded around the Summer / Autumn of this year.

8. Safeguarding

Alongside many other national governing bodies, Table Tennis England continues to champion the need for the establishment of an independent body for safeguarding, similar to that that is in place to provide oversight and consistency to anti-doping.
