1. CEO Monthly Update

2. Governance

As part of our Sport England funding, we are required to undertake an external assessment by the Child Protection in Sport Unit. This took place on the 16 May 2023. In due course we will receive a written report, however, we have been verbally informed that we have met the requirements.

3. Board Meetings

There has been no meeting of the Board since the last National Council meeting. The next Board meeting is due to take place on Tuesday 6 June 2023.

4. Russian and Belarussian Participation in International Competition

The International Olympic Committee (IOC) has recent published a series of recommendations for International Federations regarding the future participation of Russian and Belarusian nationals as neutrals in international sport. The full IOC statement, including their list of recommendations, can be found <u>here</u>.

The UK Government is currently considering the detail of this announcement and we will be engaging with the IOC as they decide how best to respond. UK Sport will keep sports updated with any further guidance from the Government.

In the meantime, the Government's 'Neutral Athlete Guidance', which can be found <u>here</u>, continues to apply and it remains the case that UK athletes are able to compete overseas against Russian and Belarusian nationals where they meet the Government's neutrality criteria.

We know that the ITTF will be considering how the IOC's recommendations should be applied to our sport and we continue to stay close to this.

5. Major Event Strategy

We continue to make positive progress towards the development of our major event strategy, including our interest the host the 2026 World Team Table Tennis Championships.

We are on track to present our bid to UK Sport to secure public investment and we expect to hear the outcome in July. We are also seeking to secure support from the Greater London Authority.

We are now working through Stage 2 of the ITTF process and this will be submitted by the deadline of 28 June.

We now have confirmation that the ITTF Summit will be held in Bangkok and the AGM will decide the host for the Championships on 24 August 2023.
